CRHA FUTURITY

GENERAL PROVISIONS:

CRHA Futurities will be held in conjunction with the CRHA National Show. To be eligible, the owner and exhibitor of a nominated horse must be current CRHA member(s) in good standing. Any owner may nominate as many entries as desired. Ownership of a futurity entry does not affect eligibility as long as new owner is a CRHA member in good standing and the transfer is reported to the CRHA Executive Secretary and Futurity Chairperson, and the futurity nomination transfer fee (\$5) is paid at the time of transfer.

It is the owner's responsibility to remit payments on time and to be acquainted with all rules and provisions. All checks or money orders should be made payable to CRHA, have Futurity written on the memo line, and mailed to the Executive Secretary with CRHA National Show entries. Returned checks will be charged the appropriate rate in accordance with CRHA rules.

*All Futurity entries must be CRHA registered, entered and shown in the corresponding CRHA National class.

ex: Weanling Filly must also be entered 2017 Halter Fillies class.

Futurity and CRHA Class will run concurrently, but only paid futurity nominees will be placed in the futurity division.

Foals resulting from a Breeding purchased through the CRHA Stallion Service Auction or Stallion Service Auction Stallion Owners (see further clarifications) who donated a service are entitled to the "Buy In rate". All other foals are eligible for entry at Nomination Rate.

Stallion Service Auction (SSA) Stallion Owners limited to <u>1 foal per donated breeding</u>, <u>regardless if</u> <u>service sold or not.</u> Buy in foal must be by a current year (2017) SSA stallion.

- Stallion Owner must designate which foal will be getting the discount before September 1st, or rate will expire.

- Stallion owner buy in does not transfer if stallion is sold.

-Stallion Owners who donate a service to the SSA will only receive one Buy in entry per Stallion service donated. Buy in foals from Stallion Owners must be by a current year (2016) SSA stallion. The foal does not necessarily have to be by their own stallion, but must be by a stallion that has donated a service for the current year.

-Buy in rate is limited to current year (2017) SSA Stallions only.

The right is reserved to reject any entry and to bar any entry from competition for failure to comply with the conditions of the futurity or CRHA rules. All entries must be in the Executive secretary's possession or post marked by the post office on or before the advertised deadline.

*** Buy in Package deal covers all 4 years of classes, and horse must be entered and shown every year or discount will expire.

****Nominations and Buy ins must be received by September 1st of the futurity year. Horses may be added from September 2nd until one (1) hour before the start of the class for double the cost of the nomination. Late fees are retained by the Futurity program, and not added to class purse. ****

FUTURITY DIVISIONS:

-Weanling Divisions:

There will be three (3) classes offered - Weanling Stallions (F1), Mares (F3) and Geldings (F5). Classes will run concurrent with appropriate sex division class.

-Yearling Halter Divisions:

There will be three (3) classes offered - Yearling Stallions (F2), Mares (F4) and Geldings (F6). Classes will run concurrent with appropriate sex division class.

-Yearling Longeline Division:

There will be one (1) classes offered – Yearling Longeline Class (F7) will run concurrent with CRHA Class 26

-2 & 3 Year Old Walk/ Trot/ Jog Division:

There will be one (1) classes offered – 2& 3 Year Old Walk/ Trot/ Jog Class (F8) will run concurrent with CRHA Class 43

CRHA FUTURITY RULES:

- 1. Futurity classes governed by CRHA Show rules
- 2. Postmark designates official date entered

3. Lunge Line: Exhibitor may show multiple horses but must have additional handler for conformation portion of class.

4. Score sheets will be posted ASAP after class is completed

5. Notification of death of horse entered, received and documented by Sept. 1, 2016, will be eligible for refund.

6. Any discrepancies/infractions must be brought to attention of Futurity Chairperson before end of show.

7. Decisions made by Judge are final. If felt not satisfactory, an official protest must be submitted. See CRHA rules regarding an official protest.

8. Prize monies (checks) not cashed by December 31 of same year considered void.

Any rules herewith can be changed, added to, or denied at the discretion of the Futurity Committee. The CRHA Board of Directors will have the final word in interpreting or supplementing the rules and conditions of the Futurity if the need arises.

AWARDS:

-80% OF ENTRY FEES ACCRUE TO PURSE OF CLASS INVOLVED. All classes receive Futurity and Sponsor monies. Ribbons and purse monies will be awarded through fifth place.
